

ORDER


The above entitled matter came on before the Court on February 22, 2001 upon the expedited motion of Wells Fargo Bank Minnesota, National Association ("Wells Fargo"), asking for emergency relief from stay under 11 U.S.C. §362 (d)(1). Appearances were as noted on the record. Based upon the evidence adduced at said hearing, the arguments of counsel, and the Court being fully advised of the premises,

IT IS HEREBY ORDERED:

1. The request of Wells Fargo for an expedited hearing on its motion for immediate relief from the automatic stay under 11 U.S.C. §362 (d)(1) is granted.
2. Wells Fargo's motion for immediate relief from the automatic stay of actions imposed by 11 U.S.C. 362 to exercise its rights under the security agreements dated November 11, 1997, September 13, 1999 and September 29, 2000 with regard to the promissory note and security agreement dated March 1, 1999 executed by the Debtor and covering all of the Debtor's inventory, equipment, machinery, contract rights, accounts and general intangibles is granted. Notwithstanding FED. R. BANKR. P. 4001(a)(3), this order is effective immediately.
