KNOW ALL MEN BY THESE PRESENTS, that a certain Trademark Security Agreement (the "Trademark Security Agreement") was executed by PPOM, L.L.C. 
Debtor has requested and the Secured Party has agreed to release the Trademark Collateral and terminate the Trademark Security Agreement.
