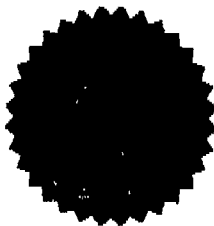

FIRST: The name and state of incorporation of each of the constituent corporations of the merger is as follows:


1. The name of the corporation is Medical Scientists, Inc. (the "Corporation").
