**ASSIGNMENT AND RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY**

THIS ASSIGNMENT AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release"), is made the 17th day of November, 2005 by Robert A. Pattillo, an individual resident in the State of Georgia, and Five Paces Ventures, L.P., a Delaware limited partnership ("Secured Parties"), in favor of Racemi, Inc., a company organized and existing under the laws of the State of Delaware ("Racemi");

W I T N E S S E T H:

WHEREAS, as collateral security for, and to secure the full payment and performance of the indebtedness evidenced by and the performance of the obligations of Racemi to the Secured Parties under the various secured obligations (the "Secured Obligations") entered into between Racemi and the Secured Parties, Racemi granted, assigned and conveyed to the Secured Parties, its entire right, title and interest in and to the trademarks and patents described more fully on the attached Exhibit A (the "Intellectual Property"); and

WHEREAS, Racemi and the Secured Parties have entered into a stock purchase agreement and other documents, in exchange for which the Secured Parties have agreed to release the Intellectual Property and assign and convey back to Racemi all right, title and interest in and to the Intellectual Property.

NOW THEREFORE, in consideration of the sum of ten dollars (\$10.00) and other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged:

Secured Parties hereby assign, convey, and transfer to Racemi the entire right, title and interest in and to the Intellectual Property, together with the good will of the business associated with the Intellectual Property; and

Secured Parties do hereby release unto Borrower, its successors and assigns, all their rights, titles, interests, claims or demands in and to the Intellectual Property; and

Secured Parties hereby agree to, and agree to execute, any documents, including but not limited to assignments and releases, including those to be filed with the United States Patent and Trademark Office, by which ownership of the Intellectual Property may be re-vested in Racemi and Secured Parties may be removed from any and all claims of ownership or interest in, or title to, the Intellectual Property.

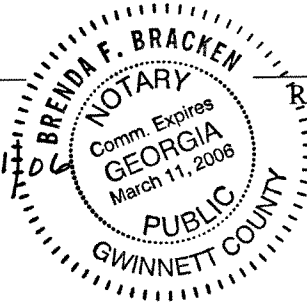

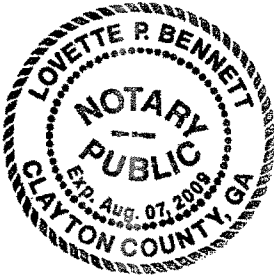
