**RELEASE OF SECURITY INTEREST IN  
INTELLECTUAL PROPERTY COLLATERAL**

This RELEASE, dated as of November 15, 2005, is made by DEUTSCHE BANK TRUST COMPANY AMERICAS (formerly known as Bankers Trust Company), as collateral agent ("Deutsche Bank"), pursuant to the termination of the Credit Agreement (the "Agreement"), by and among, Bankers Trust Company, NEXTMEDIA GROUP, INC., NEXTMEDIA OPERATING, INC., and NEXTMEDIA GROUP II, INC. (the "Grantors").

**W I T N E S S E T H**

WHEREAS, pursuant to the security interest ("Security Interest 1") granted to Bankers Trust Company by and among the Grantors, dated July 31, 2000 and recorded with the U.S. Patent and Trademark Office on October 31, 2000 at Reel/Frame No. 2173/0677, the Grantors granted Bankers Trust Company a security interest in its trademarks, registered trademarks, trademark applications, service marks, registered service marks and service mark applications, together with any goodwill connected with and symbolized by any such trademarks, registered trademarks, trademark applications, service marks, registered service marks, service mark applications; and all rights and interests pursuant to licenses or other contracts in favor of such Grantor pertaining to any trademarks, trademark registrations or trademark rights (the "Trademark Collateral");

WHEREAS, pursuant to the security interest ("Security Interest 2") granted to Bankers Trust Company by and among the Grantors, dated December 27, 2000 and recorded with the U.S. Patent and Trademark Office on January 29, 2001 at Reel/Frame No. 2232/0249, the Grantors granted Bankers Trust Company a security interest in its Trademark Collateral;

WHEREAS, pursuant to the security interest ("Security Interest 3") granted to Bankers Trust Company by and among the Grantors, dated July 31, 2000 and recorded with the U.S. Patent and Trademark Office on March 15, 2001 at Reel/Frame No. 2260/0768, the Grantors granted Bankers Trust Company a security interest in its Trademark Collateral;

WHEREAS, pursuant to the security interest ("Security Interest 4") granted to Bankers Trust Company by and among the Grantors, dated November 29, 2000 and recorded with the U.S. Patent and Trademark Office on April 16, 2001 at Reel/Frame No. 2279/0852, the Grantors granted Bankers Trust Company a security interest in its Trademark Collateral;

WHEREAS, Deutsche Bank acknowledges full payment, complete performance and satisfaction of all obligations pursuant to the Agreement have been made;

WHEREAS, the Grantors have requested that Deutsche Bank release its security interest in the Trademarks in connection with the termination of the Agreement (the "Released Collateral").

NOW, THEREFORE, in consideration of the foregoing, Deutsche Bank hereby RELEASES, without recourse and without representation or warranty, all of its security interest in the Trademarks, listed on Schedule I attached hereto and incorporated herein by reference, and any other collateral described in the Agreement.

Deutsche Bank agrees to provide the Grantors with any information and additional authorization necessary to effect the release of its security interest in the Released Collateral.
