THIRD: The number of shares outstanding at the time of the adoption for the amendment was 260. The total number of shares entitled to vote thereon was 260.

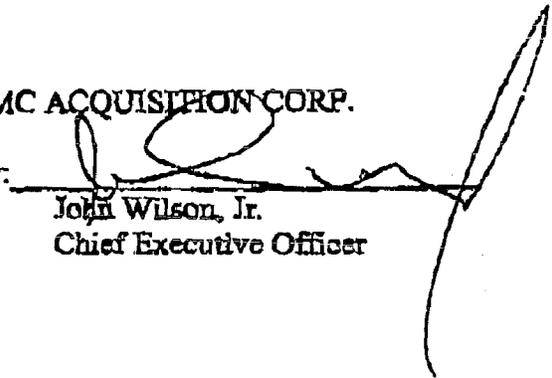
