**ARTICLES OF AMENDMENT
OF
ARTICLES OF ORGANIZATION
OF
MCKEE WALLWORK HENDERSON, LLC**

Pursuant to the requirements of the New Mexico Limited Liability Company Act § 53-19-1 et seq. (NMSA, 1978), McKee Wallwork Henderson, LLC, a New Mexico limited liability company, does hereby amend its Articles of Organization and states as follows:

3. The Articles of Organization are amended as follows:
