




WHEREAS the Assignee is desirous to acquire the Trademarks as far as international class 03 goods are concerned;


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:




1. The Assignor hereby sells, assigns and transfers unto the Assignee the whole ownership of the Trademarks as far as international class 03 goods are concerned, including all rights, title and interest in and to the Trademarks, along with each of the following:
 - the goodwill associated with and symbolised by the Trademarks;
 - all rights to proceeds of the foregoing, including any claim by the Assignor against third parties for past, present, or future infringement of the Trademarks.
 - all rights over royalties accrued until today in favour of the Assignor as a result of any contract or license entered with third parties for the use of the Trademark, and not yet cashed by the Assignor.
2. The Assignor covenants to the Assignee that the Trademarks are free from encumbrances or third party licences, except the worldwide exclusive licence and usufruct granted to Cofinluxe, a French company, residing at 6, rue Anatole de la Forge, FR – 75858 PARIS CÉDEX 17.

The Assignors specifies however that the Trademarks have been the object of a cancellation proceeding initiated by the Assignee itself, which has led to a March 10, 2004 judgement confirming the validity of the Trademarks registered in class 03. The time-limit for appeal of said judgement is June 10, 2004.

The Assignee acknowledges the previous and discharges the Assignor of any liability as regard said legal action and recognizes the full and complete validity of the present sale notwithstanding the final result of the lawsuit.

3. The Assignor covenants that at the request and cost of the Assignee it will at all times hereafter do all such acts and execute all such public and private documents as may reasonably be necessary or desirable both to secure the vesting in the Assignee herewith, to secure the registration of the assignment of Trademarks in favour of the Assignee in the corresponding registers and to assist him in the resolution in any question concerning the Trademarks.
4. The Assignor also covenants to sign any documents necessary to perfect the assignment of any and all of the Trademarks listed in Exhibit A to the Assignee.



5. In case that due to the laws of any jurisdiction in which one or several of the Trademarks are registered or applied for, it is not possible to assign and transfer the respective Trademarks to the Assignee (e.g. because in such jurisdiction a trademark cannot be transferred without the related business), the Assignor hereby grants to the Assignee an irrevocable an perpetual exclusive and royalty-free licence to use the respective Trademarks in such jurisdiction, license which shall include the power to grant sub-licenses.
6. The Assignee hereby covenants to prepare all documentation necessary and to bear all costs for such assignment.
7. Accordingly, the Assignee hereby covenants to pay to the Assignor a global consideration of EURO 3,940,000.00 (three million nine hundred and forty thousand euros).

Payment shall be made as follows:

- upon signature of this Agreement an amount of EURO 2.400.000,00 shall be paid by remittance to PROPINTELL S.A. of a bank cheque of La Caixa, drawn on UBS SA in Zürich , with n° 1920768 of same amount
- the Assignee shall further hand the Assignee 5 irrevocable promissory notes – payable to the bearer – in the following amounts:
 - EURO 200.000,00 payable May 31, 2005
 - EURO 200.000,00 payable May 31, 2006
 - EURO 200.000,00 payable May 31, 2007
 - EURO 200.000,00 payable May 31, 2008
 - EURO 740.000,00 payable May 31, 2009

8. Should any provision of this Agreement be or become invalid, the other provisions shall not be affected and the Parties shall use their reasonable endeavours to reach agreement to have the invalid provision replaced by a valid arrangement which comes as close as possible to the purpose of the invalid provision and to the intention of the Parties related to such provision.
9. Except if applicable law or this Agreement require the exercise of a right within a certain period of time, no delay on the part of the Parties in exercising any right, power or privilege hereunder shall operate as a waiver thereof, nor shall any waiver or partial exercise on the part of the Parties on any right, power or privilege hereunder, preclude any other or further exercise thereof or the exercise of any other right, power or privilege which is not precluded by this Agreement.
10. Modification of any provision of this Agreement (including this clause 10) may only be made in writing and signed by duly authorised officers of both Parties.

11. This Agreement shall be governed by and construed in accordance with the laws of Switzerland, without giving effect to conflict of law principles.
12. Any dispute, controversy or claim arising out of or in relation to this Agreement, including the validity, invalidity, breach or termination thereof, shall be settled by arbitration in accordance with the Swiss Rules of International Arbitration of the Swiss Chambers of Commerce in force on the date when the Notice of Arbitration is submitted in accordance with these Rules.

The Chamber of Commerce to which the notification of arbitration shall be addressed as per art 3.1 of the rules shall be that of Geneva, and none other.

The number of arbitrators shall be three. The seat of the arbitration shall be in Geneva. The arbitral proceedings shall be conducted in French.

IN WITNESS THEREOF, the Parties hereto by officers duly authorised, have executed this Agreement as of the date first written above.

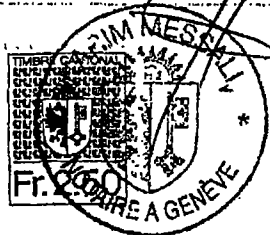
