## TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement ("Agreement") is made as of March 31, 2004, by and between EDventure Holdings, Inc., a New York corporation ("Assignor") and CNET Networks, Inc., a Delaware corporation ("Assignee").

WHEREAS, ASSIGNEE acquired substantially all of the assets of the ASSIGNOR on April 19, 2004; and



ASSIGNOR further covenants that it will execute all documents, papers, forms and authorizations and take all other actions that may be necessary for securing, completing, or vesting in ASSIGNEE full right, title, and interest in the Marks.


