WHEREAS, ASSIGNOR is the owner of the federal trademark registrations relating to the Trademarks identified below (collectively, the "Registrations");


WHEREAS, ASSIGNEE desires to acquire all rights, title, and interest in and to the Trademarks and Registrations; and
