CERTIFICATE OF MERGER

of

SI CONCRETE SYSTEMS LLC
(a Delaware limited liability company)

with and into

SI CONCRETE SYSTEMS CORPORATION
(a Delaware corporation)

Pursuant to Section 264 of the Delaware General Corporation Law and Section 18-209 of the Delaware Limited Liability Company Act.

The undersigned corporation does hereby certify that:

FIRST: The constituent entities (the "Constituent Entities") participating in the merger herein certified (the "Merger") are:

(i) SI Concrete Systems LLC, which is a limited liability company formed under the laws of the State of Delaware ("Concrete LLC"); and

(ii) SI Concrete Systems Corporation, which is a corporation organized under the laws of the State of Delaware ("Concrete Corp").

SECOND: An Agreement and Plan of Merger, dated as of October 14, 2005 by and between Concrete LLC and Concrete Corp (the "Agreement and Plan of Merger") has been approved, adopted, certified, executed and acknowledged by each of the Constituent Entities in accordance with the provisions of subsection (c) of Section 264 of the Delaware General Corporation Law and the provisions of Section 18-209 of the Delaware Limited Liability Company Act.

THIRD: Under the terms of the Agreement and Plan of Merger, Concrete LLC will merge with and into Concrete Corp. The name of the surviving corporation in the Merger shall be SI Concrete Systems Corporation (the "Surviving Corp").

FOURTH: The Certificate of Incorporation of the Surviving Corp is hereby amended and shall read as set forth in Exhibit A hereto, and shall remain in full force and effect until amended or changed pursuant to the provisions of the Delaware General Corporation Law.

FIFTH: The executed Agreement and Plan of Merger is on file at an office of the Surviving Corp, the address of which is as follows:

SIXTH: A copy of the Agreement and Plan of Merger will be furnished by the Surviving Corp, on request and without cost, to any member of Concrete LLC or stockholder of Concrete Corp.

SEVENTH: This Certificate of Merger shall be effective as of the date and time it is filed with the Secretary of State of the State of Delaware.
