TRADEMARK RELEASE AGREEMENT

This TRADEMARK RELEASE AGREEMENT (this "Agreement") is made as of November 18, 2005, by and between SunTrust Bank, a Georgia bank located at 303 Peachtree Street, 3rd Floor, Atlanta, Georgia 30308 (formerly known as SunTrust Bank, Atlanta) (the "Agent"), as agent for itself, the Lenders (as defined below) and the Issuing Banks (as defined below), and El Pollo Loco, Inc., a Delaware corporation located at 3333 Michelson Drive, Suite 550, Irvine, California 92612 (the "Grantor").

WITNESSETH:

WHEREAS, the Grantor, EPL Intermediate, Inc., the lenders party thereto (the "Lenders"), SunTrust Bank, Atlanta, as issuing bank (together with any other person or entity who was designated as an Issuing Bank pursuant to the Credit Agreement (as defined below), the "Issuing Banks") and the Agent are parties to that certain Credit Agreement, dated as of December 29, 1999 (as the same may have been modified, amended, restated or supplemented, the "Credit Agreement"), pursuant to which the Lenders agreed to extend credit to the Grantor from time to time and the Grantor granted a security interest in all of its personal property to the Agent for the benefit of the Agent, the Lenders and the Issuing Banks (the "Lender Group");

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of December 29, 1999, between the Grantor and the Agent (the "Trademark Security Agreement"), a security interest, with power of sale to the extent permitted by applicable law, was granted by the Grantor to the Agent, for the benefit of the Lender Group, in certain Collateral (as hereinafter defined) (the "Security Interest");

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office (PTO) on January 15, 2000, at Reel 002025, Frame 0039;

WHEREAS, the Grantor has requested that the Agent terminate and release the entirety of its Security Interest in the Collateral and the Agent desires to terminate and release the entirety of its Security Interest in the Collateral; and

NOW, THEREFORE, for good and valuable consideration, including the complete payment, performance and satisfaction of all Obligations (as defined in the Credit Agreement) other than contingent Obligations which expressly survive the termination of the Credit Agreement, the receipt and adequacy of which are hereby acknowledged, the Agent hereby terminates and releases the Security Interest in the following (collectively, the "Collateral");


All of the Grantor's trademarks, trade names, registered trademarks and service marks, including, without limitation, the United States trademarks and service marks, including those listed on Schedule I attached hereto, and (i) all registrations, applications, recordings and common-law rights relating thereto; (ii) all renewals thereof; (iii) all income, royalties, damages and payments now and hereafter due and/or payable with respect thereto, including, without limitation, damages and payments for past, present and/or future infringements and dilutions thereof; (iv) the right to sue for past, present and future infringements and dilutions thereof; (v)

the goodwill of the Grantor's business symbolized by the foregoing and connected therewith, and (vi) all rights corresponding thereto throughout the world.

The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the termination and release of the Security Interest contemplated hereby.
