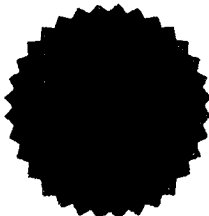

**CERTIFICATE OF CONVERSION
TO
DELAWARE LIMITED PARTNERSHIP**

Pursuant to the provisions of Section 266 of the General Corporation Law of the State of Delaware (the "DGCL") and Section 17-217 of the Delaware Revised Uniform Limited Partnership Act (the "DRULPA"), the undersigned, Airtron, Inc., a Delaware corporation (the "Corporation"), hereby certifies to and authorizes the filing with the Secretary of State of Delaware the following Certificate of Conversion, converting the Corporation into Airtron, L.P.:

ARTICLE ONE

The Corporation was formed as a limited liability company in Delaware on April 22, 2003, under the name "Air Acquisition, LLC." On May 1, 2003, Air Acquisition, LLC was converted to a Delaware corporation under the name "Airtron Acquisition, Inc."

ARTICLE TWO

The name of the Corporation immediately prior to the filing of this Certificate of Conversion is Airtron, Inc.

ARTICLE THREE

The name of the limited partnership into which the Corporation is to be converted, as set forth on its Certificate of Limited Partnership, as filed with the Secretary of State of Delaware to become effective on January 31, 2005, is Airtron, L.P. (the "Partnership").

ARTICLE FOUR

Pursuant to Section 103(d) of the DGCL and Section 17-217(c)(4) of the DRULPA, notwithstanding the date of filing of this Certificate of Conversion with the Secretary of State of Delaware, the conversion effected hereby shall become effective as of 11:59 p.m. on January 31, 2005.

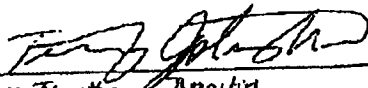
ARTICLE FIVE
