RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

WHEREAS, by a certain Intellectual Property Security Agreement dated as of October 7, 2002 (as amended from time to time, the "Security Agreement") by and between Cruise411.com, Inc. as defined in the Security Agreement as "Grantor") and Comerica Bank, successor by merger to Comerica Bank - California (as defined in the Security Agreement as the "Bank"), the Grantor granted to the Bank a security interest in and lien on certain copyrights, patents and trademarks as defined in said Security Agreement (collectively the "Intellectual Property Collateral") owned by the Grantor and set forth in Exhibits A, B and C hereto.


