Articles of Amendment of the Articles of Incorporation of NORTHWEST CRUISIN COFFEE FRANCHISE, INC., a Washington corporation, are herein executed by said corporation, pursuant to the provisions of RCW 23B.10, as follows:

1. The name of the corporation is NORTHWEST CRUISIN COFFEE FRANCHISE, INC.
2. The following amendment to the Articles of Incorporation was adopted by the shareholders of the corporation on February 7th, 2003

The name of the corporation shall be CRUISIN COFFEE FRANCHISE, INC. and its existence shall be perpetual.


