## Declaration on the global Transfer and Re-Registration of Trademarks

The parties MADAUS AG, located at: Colonia Allee 15, 51067 Cologne, Germany, and MADAUS GmbH, also located at: Colonia Allee 15, 51067 Cologne, Germany, both pharmaceutical companies constituted and existing under the Laws of the Federal Republic of Germany, wish to effect a global trademark re-registration.

MADAUS AG has by virtue of a Spin-Off-Agreement dated June 9, 2005 under the German Legislative Act on Change of Legal Form, "Umwandlungsgesetz", of October 28, 1994, transferred all its assets and liabilities related to its pharmaceutical division to MADAUS GmbH.

This transfer included the assignment of all trademarks registered in the name of MADAUS AG as well as pending trademark registrations worldwide, together with the goodwill connected with the use of these trademarks, so that with the signing date of the above said Spin-Off-Agreement MADAUS GmbH became according to the Laws of the Federal Republic of Germany the sole and only owner of the said trademarks.

Furthermore, since MADAUS AG is the legal successor of the firm "Dr. Madaus GmbH & Co", that in turn was the legal successor of the firm "Dr. Madaus & Co.", which herewith is proven by the Annex "Certificate of Local Court Köln, Ref. HRB 19451, of February 14, 2005", the trademark transfer included not only all trademarks that are registered or filed in the name of MADAUS AG, but also of any trademark that may be still registered in any national or international trademark register in the name of "Dr. Madaus & Co." or in the name of "Dr. Madaus GmbH & Co".

In the light of the aforesaid MADAUS AG agrees that MADAUS GmbH requests with the national and international Trademark Offices for recordation of the change of ownership from MADAUS AG to MADAUS GmbH
