TRADEMARK ASSIGNMENT

WHEREAS, Assignor has adopted and used the trademark COBRA for “insulating tape for electrical or plumbing uses” (the “Mark”);


WHEREAS, Assignor is the owner of U.S. Trademark Registration No. 1516393 for the Mark for “insulating tape for electrical or plumbing uses” (the “Registration”);

WHEREAS, it is the purpose of this document to memorialize the assignment and transfer in a form suitable for recordation in the United States Patent and Trademark Office.

NOW, THEREFORE, for the good and valuable consideration set forth in the Letter Agreement, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, assigns and transfers to Assignee all right, title and interest in and to the Mark and the Registration, together with the goodwill of the business symbolized by the Mark.
