**TERMINATION OF INTELLECTUAL PROPERTY SECURITY AGREEMENT**

IN WITNESS WHEREOF, Secured Party has caused this Termination of Intellectual Property Security Agreement to be duly executed on the date first mentioned above.

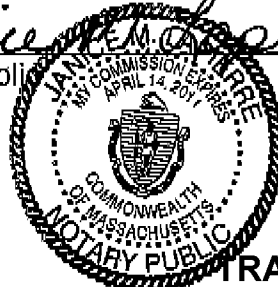
