**RELEASE AND REASSIGNMENT OF TRADEMARKS**

THIS RELEASE AND REASSIGNMENT dated June 30, 2005 by Harris N.A., as successor by merger with Harris Trust and Savings Bank;

**WITNESSETH:**

WHEREAS, Harris N.A., as successor by merger with Harris Trust and Savings Bank with its mailing address at 111 West Monroe Street, Chicago, Illinois 60603 (the "*Secured Party*") and D & K Coating Technologies, Inc., an Illinois corporation, formerly known as Venture Coating Technologies, Inc., with its mailing address at 1795 Commerce Drive, Elk Grove Village, Illinois 60007 (the "*Debtor*") are parties to a certain Trademark Collateral Agreement dated February 11, 2003 which was recorded in the United States Patent and Trademark Office on February 14, 2003 at Reel 002670, Frame 0673, pursuant to which the Debtor granted a security interest in and collateral assignment of certain trademarks, trademark registrations and trademark applications listed on Schedule A-1 attached hereto, trademark licenses listed on Schedule A-2 attached hereto, and certain other property (collectively, the "*Trademarks*"); and

- (iii) All proceeds of the foregoing, including without limitation any claim by Debtor against third parties for damages by reason of past, present or future infringement of any trademark or trademark registration listed on Schedule A-1 hereto or of any trademark licensed under a trademark license listed on Schedule A-2 or by reason of injury to the goodwill associated with any such trademark, trademark registration or trademark license, in each case together with the right to sue for and collect said damages.
