

TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (the "Agreement") is entered into as of this 20th day of Nov, 2005 (the "Effective Date") by and among Huhtamaki Consumer Packaging, Inc., a Delaware corporation having a principal place of business at 9201 Packaging Drive, De Soto, Kansas 66018 ("Assignor"), and Huhtamaki Finance B.V., a Netherlands corporation having a principal place of business at Jupiterstraat 102, NL-2132 HE Hoofddorp, Netherlands ("Assignee").

WHEREAS, Assignor has adopted, used, and is using the marks shown on Exhibit A attached hereto (the "Marks") in its business all of which are now pending applications in the United States Patent and Trademark Office; and

WHEREAS, Assignee desires to acquire the entire right, title and interest in and to said Marks, the applications therefor, and the goodwill associated therewith.

NOW, THEREFORE, to all whom it may concern, be it known that for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby makes the transfer and assignment of all rights in the Marks as follows:

1. Assignor hereby sells, assigns, transfers and sets over unto Assignee all of Assignor's right, title and interest, anywhere in the world, in and to the Marks and the applications therefor, together with the goodwill of the business in connection with which the Marks are used and that part of the goodwill of the business connected with the use of and symbolized by the Marks;
2. Assignor further covenants and agrees that it will, at any time upon request, execute and deliver any and all documents that may be necessary or desirable to perfect Assignee's rights in and to the Marks; and
3. This Assignment includes any and all rights to past and future causes of action for infringement of the marks including the right to recover damages for past infringement thereof. Further, Assignor agrees to cooperate in any such actions to the extent reasonably required by Assignee to enforce the rights transferred hereunder.

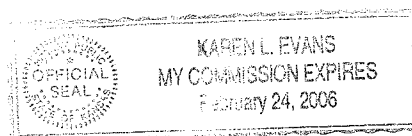
