**RELEASE AND REASSIGNMENT OF TRADEMARKS**

THIS RELEASE AND REASSIGNMENT dated June 30, 2005 by Harris N.A., as successor by merger with Harris Bank Elk Grove, N.A.:

**WITNESSETH:**
