**ASSIGNMENT OF TRADEMARKS**

This Trademark Assignment Agreement (hereinafter "Assignment" or "Agreement"), is made as of December 2, 2005 ("Effective Date"), by and between Solana MedSpas Franchise Corp., a California corporation, with its principal place of business of 18301 Von Karman, Suite 550, Irvine, California 92612 (hereinafter "Assignor"), and Nouvisage, Inc., with its principal place of business at 18301 Von Karman, Suite 550, Irvine, California 92612 (hereinafter "Assignee").

WHEREAS, Assignor is the lawful owner of the following registered trademarks for the operation of management services organizations, providing administrative services to health care professionals within a medical spa environment:

At Assignee's request, Assignor will promptly take such other action including, without limitation, the prompt execution and delivery of documents in recordable form, as may be reasonably necessary, to secure, perfect, protect or enforce the rights and interests of Assignee in and to the Marks.
