### 1. Assignment





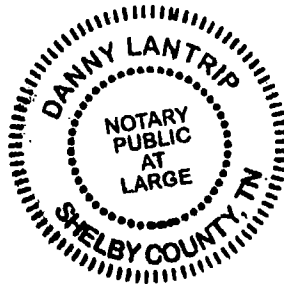
