NOW, THEREFORE, in consideration for the payment to Assignor of \$10.00, and other legally sufficient and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by Assignor, Assignor DOES HEREBY assign and transfer to Assignee all right, title and interest in and to the Proprietary Rights.
