RELEASE OF SECURITY INTEREST IN TRADEMARKS, PATENTS AND COPYRIGHTS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS, PATENTS AND COPYRIGHTS dated as of [2005] 2005, by Lehman Commercial Paper, Inc. ("Security Agent") as agent for the lenders, grants a release of security interest in trademarks, patents and copyrights to each of the companies listed on Schedule A hereto (collectively, the "Pledgors") as follows:

WHEREAS, pursuant to the Security Agreement, certain of the Pledgors as listed on Schedule B hereto and the Security Agent entered into grants of trademark security interests dated as specified in Schedule B hereto (each a "Grant of Trademark Security Interest") by which each such Pledgor granted to the Security Agent a continuing security interest in, and continuing lien upon, all right, title and interest of such Pledgor in and to the Trademark Collateral (as such term is defined in each such Grant of Trademark Security Interest) including the trademarks and service marks listed against such Pledgor's name on Schedule B hereto, which Grant of Trademark Security Interest was recorded in the Trademark Division of the United States Patent and Trademark Office; and

WHEREAS, pursuant to the Security Agreement, certain of the Pledgors as listed on Schedule C hereto and the Security Agent entered into grants of patent security interests dated as specified on Schedule C hereto (each a "Grant of Patent Security Interest") by which each such Pledgor granted to the Security Agent a continuing security interest in, and continuing lien upon, all right, title and interest of such Pledgor in and to the Patent Collateral (as such term is defined in each such Grant of Patent Security Interest) including the patents listed against such Pledgor's name on Schedule C hereto, which Grant of Patent Security Interest was recorded in the Patent Division of the United States Patent and Trademark Office; and

WHEREAS, pursuant to the Security Agreement, certain of the Pledgors as listed on Schedule D hereto and the Security Agent entered into grants of copyright security interests dated as specified on Schedule D hereto (each a "Grant of Copyright Security Interest") by which each such Pledgor granted to the Security Agent a continuing security interest in, and continuing lien upon, all right, title and interest of such Pledgor in and to the Copyright Collateral (as such term is defined in each such Grant of Copyright Security Interest) including the copyrights listed against such Pledgor's name on Schedule D hereto, which Grant of Copyright Security Interest was recorded in the United States Copyright Office; and


WHEREAS, pursuant to the Security Agreement, the Pledgors have fulfilled their respective obligations and commitments and the Security Agent has agreed to release its continuing security interest in, and continuing lien upon, and assign to each of the Pledgors, respectively, any and all interest it may have in the Trademark Collateral, Patent Collateral and Copyright Collateral (collectively, the "Collateral") of each of the Pledgors.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged:

1. The Security Agent hereby releases its continuing security interest in, and continuing lien upon, and assigns its entire right, title and interest in, if any, all Trademark Collateral, Patent Collateral and Copyright Collateral.
2. This RELEASE OF SECURITY INTEREST IN TRADEMARKS, PATENTS AND COPYRIGHTS has been executed and delivered by the Security Agent for the purpose of releasing, removing, or otherwise eliminating each Grant of Trademark Security Interest, each Grant of Patent Security Interest and each Grant of Copyright Interest executed in favor of the Security Agent in the Trademark Collateral, Patent Collateral and Copyright Collateral, respectively, that has been filed with the United States Patent and Trademark Office or the United States Copyright office (as applicable) and, to the extent required, any other such offices in other countries of the world. Each of the Pledgor's respective obligations under the Grant of Trademark Security Interest, Grant of Patent Security Interest and Grant of Copyright Security Interest to which it is a party are thus terminated as of the date first set forth above.
3. The Security Agent has a continuing obligation to sign all agreements and documents necessary to carry out this Agreement and the obligations herein.
4. This Agreement shall be binding upon each of the Pledgor's legal representatives, successors and assigns.
5. Subject to estimates agreed prior to the date hereof, the Pledgors shall promptly pay to the Security Agent on demand all costs and expenses (including legal fees and any value added tax or other similar tax thereon) reasonably incurred by the Security Agent in connection with the releases given by this Agreement and the preparation, negotiation and execution of this Agreement.
