**RELEASE OF SECURITY INTEREST IN
TRADEMARK COLLATERAL**

This RELEASE, dated as of December 6, 2005, is made by Lehman Commercial Paper Inc., as Administrative Agent (in such capacity, the "Administrative Agent") in favor of Network Distribution International, Inc., a Massachusetts Corporation; Network Distribution International, a Massachusetts Business Trust; and Bellwether Distribution, LLC, a Delaware Limited Liability Company (collectively referred to herein as "Network Distribution").

W I T N E S S E T H

WHEREAS, pursuant to the Grant of Security Interest, dated November 23, 2003 (the "Grant of Security Interest"), recorded with The United States Patent and Trademark Office on December 4, 2003 at Reel/Frame No. 2874/0987, Network Distribution granted the Administrative Agent a security interest in its trademarks and registrations therefore, including goodwill (the "Trademark Collateral");

WHEREAS, Network Distribution has satisfied all of the obligations contained in the Security Agreement (as defined in the Grant of Security Interest);

WHEREAS, Network Distribution has requested that the Administrative Agent release and terminate its security interest in the Trademark Collateral.

NOW, THEREFORE, the Administrative Agent, hereby RELEASES and reconveys all of its right, title and interest in and to any and all security interests granted to the Administrative Agent by Network Distribution pursuant to the Grant of Security Interest in the Trademark Collateral, including but not limited to the trademarks set forth in Schedule A.

The Administrative Agent agrees to provide Network Distribution, at Network Distribution's expense, with any additional authorization, and will execute, at Network Distribution's expense, any documents reasonably necessary to effect and record the release of the Administrative Agent's security interest in the Trademark Collateral.
