RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), dated as of December 9, 2005, is made by The Governor and Company of the Bank of Scotland, as Security Agent ("Agent"), in favor of Environmental Resources Management-Southeast, Inc. ("Grantor") as follows:

WHEREAS, Grantor and Agent are parties to a certain Security and Pledge Agreement, dated as of February 28, 2001, as amended and restated as of March 22, 2005 (the "Security and Pledge Agreement"); and

WHEREAS, pursuant to the Security and Pledge Agreement, Grantor and Agent entered into a Grant of Trademark Security Interest dated March 30, 2001 (the "Grant of Trademark Security Interest"), under which Grantor granted to Agent a continuing security interest in, and continuing lien upon, all right, title, and interest of Grantor in and to the Trademark Collateral (as defined in the Grant of Trademark Security Interest), including the service mark listed on the attached **Schedule A**, which Grant of Trademark Security Interest was recorded with the United States Patent and Trademark Office ("USPTO") on April 11, 2001, at Reel/Frame No. 2281/0380; and

WHEREAS, pursuant to the Security and Pledge Agreement, Grantor has fulfilled its obligations and commitments and Agent has released and has agreed to release its continuing security interest in, and continuing lien upon, any and all interest it may have in the Trademark Collateral; and

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged:

1. Agent hereby releases and reconveys back to Grantor its continuing security interest in, and continuing lien upon, the Trademark Collateral, which security interest and lien had been granted pursuant to the Grant of Trademark Security Interest.
2. This Release shall be binding upon Grantor's legal representatives, successors, and assigns.
3. This Release may be executed in counterparts, each of which shall be deemed to be an original but all of which together shall constitute one and the same instrument.


