RELEASE OF SECURITY INTEREST

WHEREAS, U.S. Mills, Inc., a Delaware corporation, with offices at 200 Reservoir Street, Needham, Massachusetts 02494, on March 29, 2002 granted a security interest in the federal trademark applications and registrations shown on the attached Schedule A (collectively the "Marks") to Boston Private Bank and Trust Company and TD Banknorth, Inc. 
