NOTICE OF RELEASE OF
SECURITY INTEREST IN TRADEMARKS

Reference is made to a Security Agreement dated December 29, 1998, recorded at the United States Patent and Trademark Office at Reel 001836 and Frame 0848 on January 5, 1999 (the "Security Agreement"), made by Fresh Choice, Inc. Finova Capital Corporation's execution of and/or delivery of any documents releasing any security interest or claim in any property of the Borrowers as set forth herein is made without recourse, representation, warranty or other assurance of any kind by Finova Capital Corporation, including as to the condition or value of any collateral.

This release shall be governed by and construed in accordance with the laws of the State of California without regard to conflicts of law principles.
