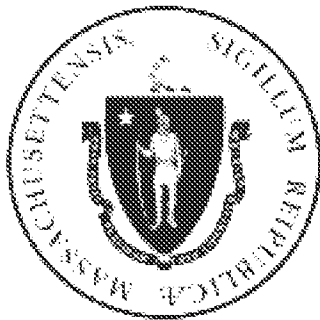

- 1) On January 16, 2002, a change of name from Nicolet Biomedical, Inc. to Thermo Biomedical, Inc. was recorded with the PTO at reel/frame 2430/0254 against (in part) the three registrations referenced above.
- 2) On January 18, 2002, a change of name from Thermo Biomedical, Inc. to Viasys Healthcare Inc. was recorded with the PTO at reel/frame 002436/0324 against (in part) the three registrations referenced above.
- 3) Nicolet Biomedical, Inc. did not own the above-referenced registrations at the time of the recordation of the initial name change. Thermo Biomedical Inc. did not own the above-referenced registrations at the time of the subsequent name change. Both of these recordations were made in error as to the three registrations.
