For each Trademark assigned hereunder that is registered with the Secretary of State of Oklahoma, this Assignment shall be limited to such Trademark, registration and associated goodwill only as it relates to uses of the Trademark within the territorial boundaries of the State of Oklahoma and/or within Designated Market Areas (as such term is defined by Nielsen Statistical Index) having a Central Area (as such term is defined by Nielsen Statistical Index) located within the State of Oklahoma.

The USPTO, Secretary of State and NSI are requested to direct any correspondence after the date hereof to Assignee, in each case c/o David F. Griffin, 7401 N. Kelley Avenue, Oklahoma City, Oklahoma 73111.

This Assignment is binding on Assignor and its successors and assigns and shall inure to the benefit of Assignee and its successors and assigns.

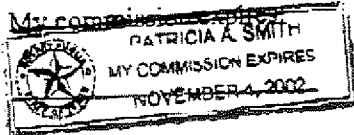
