IN INTELLECTUAL PROPERTY**

**RECITALS:**

- A. Bioniche Life Sciences Inc. (the "**Debtor**"), a Canadian corporation with its head office at 231 Dundas Street East, Belleville, Ontario K8N 1E2 is the owner of the trade-marks set forth in Exhibit "A", the registrations and applications for the trade marks identified therein and the underlying goodwill of said trade marks (collectively, the "**Trade-Marks**");
- B. The Debtor is the owner of the patents set forth in Exhibit "B", the registrations and applications for the patents identified therein and the underlying goodwill of said patents (collectively the "**Patents**" and together with the Trademarks, the "**Intellectual Property**"); and
- C. Laurus Master Fund, Ltd. ("**Laurus**") has entered into an agreement with the Debtor, as reflected by a separate document entitled Master Security Agreement dated as of *December 2*, 2005 made between, inter alia, the Debtor in favour of Laurus, as amended, modified, supplemented or replaced from time to time (the "**Security Agreement**") by which the Debtor granted to Laurus a security interest in certain property, including the Intellectual Property, in consideration of, inter alia, the provision of credit facilities by said lenders in favour of the Debtor.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are acknowledged and in accordance with the terms and obligations set forth in the Security Agreement, the Debtor confirms the grant to Laurus of a security interest in and to the Intellectual Property.
