**ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION**

Pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act, the undersigned corporation adopts the following articles of amendment to its articles of incorporation:

ARTICLE ONE

The name of the corporation is M.L. KUHN ENTERPRISES, INC.

ARTICLE TWO

The following amendment to the articles of incorporation was adopted by the shareholders of the corporation on June 19, 1997.

The amendment alters or changes ARTICLE ONE of the original articles of incorporation and the full text of each provision altered is as follows:

ARTICLE THREE

The number of shares of the corporation outstanding at the time of such adoption was 1,000; and the number of shares entitled to vote thereon was 1,000.


