WHEREAS, the Security Assignment was recorded with the United States Patent and Trademark Office on June 19, 2001 at reel 2320, Frame 0874; and


WHEREAS, the Security Assignment was recorded by the Patent and Trademark Office as an actual assignment of the Marks to Agent; and
