**RELEASE OF SECURITY INTEREST IN  
TRADEMARK COLLATERAL**

This RELEASE, dated as of December 6, 2005, is made by Bank One, NA, as collateral agent (in such capacity, the "Collateral Agent") in favor of Varn International, Inc., a Delaware Corporation ("Varn International").

**WITNESSETH**

WHEREAS, pursuant to the Grant of Security Interest, dated June 29, 2001 (the "Grant of Security Interest"), recorded with The United States Patent and Trademark Office on September 14, 2001 at Reel/Frame No. 2371/0432, Varn International granted the Collateral Agent a security interest in its trademarks and registrations therefore, including goodwill (the "Trademark Collateral");

WHEREAS, Varn International has satisfied all of the obligations contained in the Security Agreement (as defined in the Grant of Security Interest);

WHEREAS, Varn International has requested that the Collateral Agent release and terminate its security interest in the Trademark Collateral.

NOW, THEREFORE, the Collateral Agent, hereby RELEASES and reconveys all of its right, title and interest in and to any and all security interests granted to the Collateral Agent by Varn International pursuant to the Grant of Security Interest in the Trademark Collateral, including but not limited to the trademarks set forth in Schedule A.

The Collateral Agent agrees to provide Varn International with any information and additional authorization, and will execute any documents necessary to effect, record, and perfect the Release of the Collateral Agent's Security Interest in the Trademark Collateral.
