Assignors further represent and warrant that they have not transferred, assigned, hypothecated or granted a security interest in the Trademarks to any third party.

FURTHER, other than the registration identified on Exhibit A hereto and abandoned Application Serial No. 75/812,761 for the mark VENUS.COM, Assignors represent and warrant that they have neither applied for nor obtained any other domestic or international trademark or service mark registrations for "VENUS" or variations thereof, including but not limited to VENUS.COM.

FURTHER, Assignors agree to execute and provide promptly after their execution hereof, such further instruments, documents or assignments as may be reasonably necessary to effectuate the purposes of this transaction and to consolidate, vest and record in Assignee their rights in and to the Trademarks.
