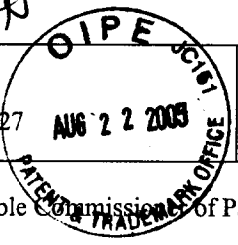



RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of August 15, 2005 (this "Release"), is made by Comerica Bank, N.A. (the "Lender"), with respect to that certain Amended and Restated Loan and Security Agreement dated as of May 6, 2004, and that certain Amended and Restated Intellectual Property Security Agreement effective as of May 6, 2004, the latter having been recorded in the records of the United States Patent and Trademark Office at Trademark Reel 3022, Frame 0130 (collectively, the "Security Agreements"), between Alex eSolutions, Inc. (the "Grantor"), and the Lender.

WITNESSETH:


WHEREAS, pursuant to the Security Agreements, the Grantor granted to the Lender a security interest in certain of the Grantor's trademarks set forth on Schedule A hereto, including the registrations and pending applications therefor and the goodwill of the Grantor's business symbolized thereby (the "Trademark Collateral"); and

WHEREAS, the Lender wishes to: (i) release all of its security interest covering the Trademarks; (ii) restore all right, title and interest in and to the Trademark Collateral to the Grantor; and (iii) dissolve any and all liens and encumbrances with respect to the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Lender does hereby release its security interest in the Trademark Collateral, and discharges, quit claims and relinquishes unto the Grantor (in each case without recourse and without any representation or warranty) any and all right, title and interest it has in and to the Trademark Collateral.
