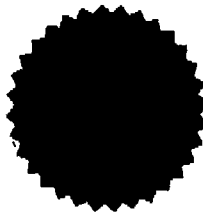

1. The name of the corporation is KMV Technologies, Inc.
2. The original Certificate of Incorporation of KMV Technologies, Inc. was filed with the Delaware Secretary of State on January 27, 2003 and a Restated Certificate of Incorporation was filed with the Delaware Secretary of State on March 25, 2003.
