3 **WHEREAS, CARGILL, INCORPORATED**, a corporation organized and existing under  
4 the laws of the State of Delaware, located and doing business at 15407 McGinty Road, West  
5 Wayzata, Minnesota 55391, (hereinafter the "ASSIGNOR") is the owner of the trademark LO  
6 SALT and Design and the U.S. registration thereof, Reg. No. 1,434,866, dated March 31, 1987;

7 **WHEREAS, ASSIGNOR** has used its trademark LO SALT and Design, having first used  
8 it on June 22, 1976, and has not abandoned said mark or its rights therein;


9 **WHEREAS, KLINGE FOODS LIMITED**, a private limited company organized and  
10 existing under the laws of Scotland, located and doing business at 1 Bessemer Drive, Kelvin  
11 Industrial Estate, East Kilbride, Glasgow G75 0QX, Scotland, (hereinafter the "ASSIGNEE") is  
12 desirous of acquiring all rights, title and interest in and to said trademark, together with  
13 registration thereof, and the goodwill of the business symbolized thereby;

14 **NOW, THEREFORE**, for good and valuable consideration, the receipt of which is hereby  
15 acknowledged, said ASSIGNOR does hereby sell, assign, and transfer unto said ASSIGNEE, its  
16 successors and assigns, all of its rights, title and interest in and to said trademark together with the  
17 registration thereof, the goodwill of the business symbolized thereby, and the right to sue and  
18 collect damages for any past or present infringement with respect to said trademark.

19 ASSIGNOR further agrees that upon ASSIGNEE'S request, and at ASSIGNEE'S expense,  
20 it will execute any and all documents reasonably necessary to vest all rights, title and interest in  
21 and to the trademark LO SALT and Design, together with the registration thereof, Reg. No.  
22 1,434,866.
