## ASSIGNMENT

**WHEREAS, ROBECO, INC.**, a New York corporation (hereinafter referred to as "Robeco") is the owner of all right, title and interest in and to, and the goodwill associated with U.S. Registration No. 1,112,561 registered December 17, 2002 for the trademark ROBANE (hereinafter referred to as the Mark), which it has used in the United States; and

**WHEREAS, BARNET PRODUCTS CORP.**, a New Jersey corporation having its principal place of business at 140 Sylvan Avenue, Englewood Cliffs, New Jersey 07632 (hereinafter referred to as "Barnet"), desires to acquire the Mark and the goodwill of the business associated with the Mark.


**NOW, THEREFORE**, for good and valuable consideration, receipt of which is hereby acknowledged, the Robeco does hereby assign and transfer to Barnet the entire right, title, and interest in and to the registration for said Mark and all of its right, title, and interest to said Mark not presently registered set forth herein, together with the goodwill of the business symbolized by the Mark and the registration thereof, and all other rights which Robeco has enjoyed thereunder in the United States, including any and all rights of recovery based on past infringement of said Mark and/or registrations, the same to be held and enjoyed by Barnet, its successors, and assigns forever and to the full end of the terms for which the aforesaid Mark is registered and any renewals of the terms thereof;

**AND FOR THE SAME CONSIDERATION**, Robeco also hereby covenants and agrees that, at the time of execution and delivery of these presents, Robeco is the sole and lawful owner of the entire right, title, and interest in and to the

said registration and believes it is the sole and lawful owner of the entire right, title, and interest to said Mark and said goodwill associated therewith and that the same are unencumbered and that Robeco has good and full right and lawful authority to sell and convey the same in the manner herein set forth;

**AND FOR THE SAME CONSIDERATION**, Robeco hereby covenants and agrees that Robeco will, whenever counsel of Barnet or the counsel of its successors, legal representatives, and assigns shall advise that it is lawful and desirable, sign all papers and documents, deliver necessary documents including original registration certificates, if available, take all lawful oaths, execute separate confirmatory assignments, and do all acts reasonably necessary or desirable to be done for the procurement, maintenance, enforcement, and defense of said Mark and registration thereof without charge to Barnet, its successors, legal representatives, and assigns, other than reasonable costs and expenses incurred by Robeco or any of its employees, agents, and representatives in connection with the foregoing actions.
