ASSIGNMENT OF TRADEMARKS

For the consideration set forth in that certain Asset Purchase Agreement dated October 18, 2004 (the "PURCHASE AGREEMENT") by and between CrossGen Entertainment, Inc., a Florida Corporation, CrossGen Intellectual Property, LLC, a Florida limited liability company, and CrossGen Technologies, LLC, a Florida limited liability company (collectively, "ASSIGNORS"), and Cal Publishing, LLC, a Delaware limited liability company (hereinafter ASSIGNEE), ASSIGNORS do hereby sell, assign, transfer, and convey to ASSIGNEE all worldwide rights, title and interest in and to, and to the use of, the trademarks and service marks identified on Schedule A attached hereto, which schedule is herein incorporated by reference, the goodwill and business symbolized thereby, and the applications and/or registrations thereof identified in said Schedule A (all of which are collectively referred to as the "MARKS"), together with the right to recover for past acts of infringement of the MARKS.

ASSIGNORS are conveying to ASSIGNEE good and marketable title to all the MARKS, free and clear of all liens and encumbrances; provided however, that this Assignment of Trademarks is subject in all respects to the provisions of the PURCHASE AGREEMENT and is not intended in any way to supersede, modify or qualify any provision of the PURCHASE AGREEMENT.


ASSIGNORS hereby covenant and agree that they will, at the request of ASSIGNEE and without further consideration, execute and deliver, and will cause their employees and agents to execute and deliver, such other instruments of sale, transfer, conveyance and assignment, and take such other action as may reasonably be necessary to more effectively sell, transfer, convey, assign and deliver to, and vest in, ASSIGNEE, its successors and assigns, good, clear, record and marketable title to the MARKS, and to put ASSIGNEE in actual possession thereof, to assist ASSIGNEE in exercising all rights with respect thereto and to carry out the purpose and intent of the PURCHASE AGREEMENT.

ASSIGNEE may hereafter file and prosecute such applications, maintain such registrations, and take such action to enforce and defend the rights hereby acquired by ASSIGNEE as ASSIGNEE in its sole discretion deems appropriate.

The United States Patent and Trademark Office is hereby authorized to deliver to ASSIGNEE, its attorneys, agents, successors or assigns, all official documents and communications as may be warranted by this Assignment of Trademarks.


