ARTICLES OF AMENDMENT
of
WOODSMITH CORPORATION

TO THE SECRETARY OF STATE OF THE STATE OF IOWA:

Pursuant to section 1006 of the Iowa Business Corporation Act, the undersigned corporation adopts the following amendment to the corporation's Articles of Incorporation.

1. The name of the corporation is Woodsmith Corporation.
2. Article I of the Articles of Incorporation be and is hereby amended to change the name of this corporation from Woodsmith Corporation to August Home Publishing Company effective as of July 1, 1995.
3. The date of adoption of the amendment was June 20, 1995.
4. The amendment was approved by the shareholders of the corporation. As of the date of the adoption of the amendment, a total of 100,000 shares of common capital stock of the corporation was outstanding and all such shares were voted in favor of the aforesaid amendment.

The effective date and time of this document and the amendment as adopted herein is July 1, 1995, at 12:01 a.m., Central Daylight Savings Time.
