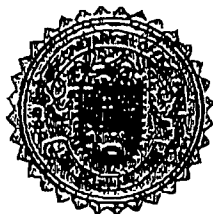

Assurant, Inc., a Delaware corporation, hereby certifies that:

1. The name and state of incorporation of each of the constituent corporations are as follows:

- (a) Fortis, Inc., a Nevada corporation ("Fortis"); and
- (b) Assurant, Inc., a Delaware corporation ("Assurant").

2. The Agreement and Plan of Merger (the "Agreement and Plan of Merger"), dated as of January 12, 2004, between Fortis and Assurant has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations in accordance with Section 252 of the General Corporation Law of the State of Delaware.

3. The name of the surviving corporation is Assurant, Inc. (the "Surviving Corporation").

4. The Restated Certificate of Incorporation of Assurant as in effect immediately prior to the merger shall be the Restated Certificate of Incorporation of the Surviving Corporation

5. The executed Agreement and Plan of Merger is on file at an office of the Surviving Corporation at One Chase Manhattan Plaza, 41st Floor, New York, New York 10005.

6. A copy of the Agreement and Plan of Merger will be furnished by the Surviving Corporation, on request and without cost, to any stockholder of any constituent corporation.

7. The authorized capital stock of Fortis is as follows:

- (i) 80,000,000 shares of Common Stock, par value \$0.10 per share; and
- (ii) 20,000,000 shares of Preferred Stock, par value \$1.00 per share.
