AND, said Assignor hereby covenants that it has full right to convey the entire interest herein assigned, along with that portion of its business which has developed the products to which the Trademarks pertain; provided, however, that Assignor makes no warranties with respect to the common law Trademarks.

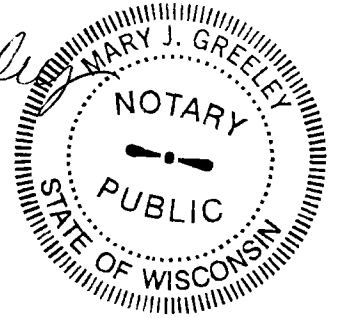
