## TRADEMARK ASSIGNMENT AGREEMENT

- Parties; Effective Date.** This Trademark Assignment Agreement ("Agreement") is entered into between Car Pak Manufacturing Company, Inc., a Michigan corporation ("Assignor") and CP Manufacturing Company, LLC, a Michigan limited liability company ("Assignee"). This Agreement is effective as of Dec. 1, 2005.
- Purpose of Agreement.** Assignor is the owner of the trademark "CAR-PAK," Application for U.S. Trademark Registration Serial No. 78/756341 (the "Mark"), and seeks to assign to Assignee, and Assignee seeks to acquire, the Mark pursuant to this Agreement.
- Assignment of Marks.** Pursuant to the Asset Purchase Agreement between the parties of even date herewith, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns, sells, transfers and conveys all right, title and interest in and to the Mark, including, without limitation: (a) all goodwill associated with the Mark, and all goodwill associated with the goods to which the Mark pertains; (b) the application for U.S. registration for the Mark, and any registrations or renewals thereof; and (c) any and all other rights, whether statutory or common law, corresponding thereto and all other rights of any kind whatsoever accruing thereunder, together in each case with the goodwill of the business connected with the use of, and symbolized by the Mark.
- Binding Effect.** This Agreement shall be binding upon and inure to the benefit of the parties' heirs, representatives, successors, and assigns.
