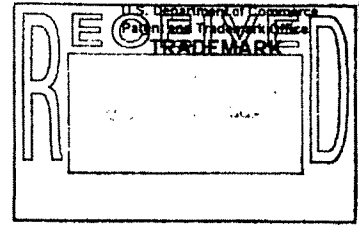

("Assignor"), and Heathkit Company, Inc., a Delaware corporation, with its principal office at 455 Riverview Drive, Benton Harbor, Michigan 49022, U.S.A. ("Assignee").

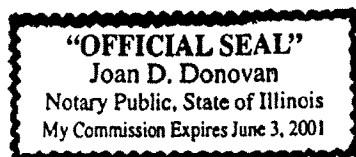
