SECOND AMENDMENT TO MEMORANDUM OF  
SECURITY INTEREST IN TRADEMARKS

Reference is hereby made to that Memorandum of Security Interest in Trademarks, dated as of November 21, 2003 (“**Memorandum of Trademarks**”) executed by Goldhil Entertainment, f/k/a “Goldhil Home Media International, Inc.,” a California corporation (“**Debtor**”), in favor of City National Bank, a national banking association (“**Secured Party**”), with respect to among other things the trademark registrations and applications listed on Schedule A attached hereto and incorporated herein by reference and the related goodwill and which Memorandum of Trademarks was recorded with the U.S. Patent and Trademark Office on December 1, 2003, Reel/Frame: 002872/0340, as amended by that certain Amendment To Memorandum of Security Interest In Trademarks, dated January 4, 2005, which was recorded with the U.S. Patent and Trademark Office on March 7, 2005 as Reel/Frame 3040/0485.

Debtor and Secured Party wish to amend the Memorandum of Trademarks as follows:

1. Debtor changed its name to “Goldhil Entertainment” on September 12, 2005.

3. As used in the Memorandum of Trademarks, the term “Credit Agreement” shall refer to that certain Accounts Receivable and Inventory Loan Agreement, dated as of November 21, 2003 by and between Debtor and Secured Party as amended by that certain Amendment to Accounts Receivable and Inventory Loan Agreement, dated as of January 4, 2005 and as amended and restated by that certain Amended and Restated Accounts Receivable and Inventory Loan Agreement, dated as of October 31, 2005, and as hereafter further amended and/or restated from time to time.
4. Except as otherwise provided herein, the Memorandum of Trademarks shall remain in full force and effect.



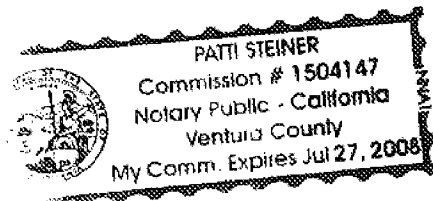


