ASSIGNMENT OF MARK

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and pursuant to the Agreement, Assignor hereby transfers, assigns, sells, conveys and delivers to Assignee, its successors and assigns, free and clear of all Liens (other than Permitted Liens), all of Assignor's rights, title and interest in and to the Mark (including, without limitation, the registrations thereof and applications therefor (wherever filed)), together with the goodwill of the business symbolized by the Mark, and all rights, claims and privileges pertaining to the Mark, including, without limitation, the right to maintain and prosecute trademark registrations and applications for the Mark and the right to sue and recover damages for past, present and future infringement of the Mark, subject to the exclusive, perpetual, royalty-free license to use the Mark granted by Buyer to Seller concurrently herewith as set forth in Section 1.3 and on Schedule 1.3 of the Agreement.

This Assignment is made pursuant to (and does not modify) the Agreement, which contains certain representations, warranties and covenants regarding the Mark. Capitalized terms used herein and not otherwise defined shall have the respective meanings set forth in the Agreement.


