

### **TRADEMARK ASSIGNMENT A**

Assignor also represents and warrants (i) that it has the unqualified right and power to enter into this Assignment and perform its terms; that it is the sole and exclusive owner of the entire right, title and interest in and to, free and clear of any liens, charges and encumbrances, of the Registrations, that Assignor has not executed, and will not execute, any agreement in conflict herewith, that the Registrations are in good standing, that the Registrations have not been adjudged invalid or unenforceable, in whole or in part by any court of competent jurisdiction, nor has any holding, decision or judgment been rendered by any governmental agency or authority which would limit or cancel the validity, registrability or enforceability of any of the Registrations, that no action or proceeding is pending seeking to limit, cancel or render the Registrations invalid, and Assignor has not granted any release, covenant not to sue, or non-assertion assurance to any third party with respect to any of the Registrations and (ii) that, to its knowledge, the Registrations are valid and enforceable, and that no claim has been made that the use of any of the Registrations does or may violate the rights of any third person.
