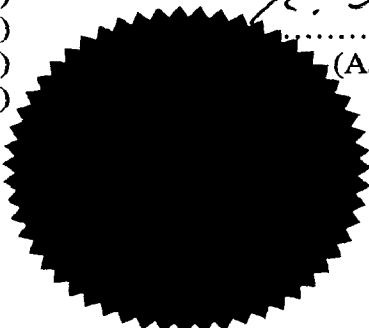

Whereas:


1. The Assignor is the Proprietor of the Patent previously referred to (hereinafter referred to as "the said Patent").

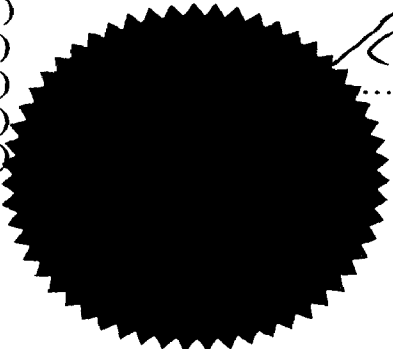


